WHAT YOU NEED TO **KNOW NOW**

If someone tells you they have experienced sexual violence and harassment, including sexual assault, sexual harassment, domestic violence, dating violence, and/or stalking - first offer support. Listen to them and provide resources listed on this card.

The person's health and safety is our primary concern. If the person's safety is an immediate concern, contact the Office of Safety and Security at (904) 819-6200 or call 911

HOW TO USE THIS CARD

This side is yours. Tear the card along the perforated edge and give the other side to the person confiding in you.

The purpose of this card is to help guide you through a tough conversation and ensure you are taking the right steps to help them.

WHAT TO SAY AFTER YOU **GIVE THE RESOURCE GUIDE**

Thank you for trusting me. Please know that I am required to refer you to our Title IX Coordinator. She will meet with you to help ensure your personal safety and emotional well-being, direct you to relevant resources, and explain what your options are if you want the College

WHAT TO KNOW

You have the right to choose who to speak with, what resources you will use, what you will say, and when you will say it. It is your choice whether to name the other person or people.

NON-RETALIATION POLICY

It is a violation of the College policy for anyone to retaliate in any way against you because you reported an incident.



YOUR OPTIONS

Consider the following actions:

- · Call 911 or the Office of Safety and Security if you are in immediate danger
- Seek medical attention
- Report the situation to the Title IX Coordinator
- Talk to a counselor
- Lean on your support system of family and friends

You do not have to choose a course. of action immediately, but consider preserving evidence* in case you choose to pursue charges.

*Possible evidence might be physical (i.e. clothing, bedding, letters, etc.) or digital (pictures, texts, emails, social media messages, etc.).
